

TERMS OF USE

1. General

These Terms of Use refer to the use of the login service on the www.car.info website (“**Service**” and “**Website**”) and are applicable between CAR INFO NORDIC AB (“**Car Info**”) and you, the (“**User**”).

The Service permits the User access to the facts about car brands, car models and specific vehicles, and to share photos of vehicles that other users upload on the Site.

2. Use of the Service

The User uses a username and password to access the Service or, alternatively, connect to the Service through a Facebook or Google account. The User agrees to choose a username and password that are difficult to hack, and undertakes not to reveal them to anybody and to store the information securely to prevent unauthorised access. Car Info will not be held liable for unauthorised use of the Service due to non-compliance of these instructions.

The information available to the User through the Service could, in some cases, be personal data. The User undertakes not to disclose or use said personal data for anything other than private, non-commercial use. Car Info will block users who fail to comply with this privacy policy.

3. Changes to the Service

Car Info reserves the right to makes changes and introduce updates to the Service without prior notice.

4. Rights

All intellectual property rights and related rights to the Service, including, but not limited to, software copyright and source code, are, and will remain, the exclusive property of Car Info. Use of the Service does not grant the User a licence or any other right of use to the Service.

Car Info reserves the right to use any images downloaded to the Website by the User for marketing purposes and any other use on the Website.

5. Personal data

Car Info is responsible for handling the personal data entered on the Car Info website by the User. Car Info uses the User's personal data to identify the User, communicate with the User and to manage the User's personal data to fulfil this agreement and provide the Service. The User's personal data could also be used in connection with marketing from Car Info and for statistics purposes.

If the User connects to the Service via their Facebook or Google account, the User will permit Car Info to gather, store and use information about the User in order to target advertisements to the User in accordance with these Terms of Use. The User also permits Car Info to share this information on Facebook and Google.

Once a calendar year, the User is entitled to request details of their personal data compiled by Car Info regardless of how the information is compiled. Users requiring

such information must provide Car Info with a signed written request. The request must be in writing to comply with the Personal Data Act and cannot be sent by email. If the User's personal data is used in violation of the Personal Data Act, the User is entitled to demand that the personal data be corrected, blocked or deleted. The User may at any time request that their personal data not be used for marketing purposes.

6. Accessibility and Liability

The service is provided to the User without any support commitments. Also, Car Info makes no representations, express or implied, as to the Service, its design, functionality or availability. This means that Car Info has no liability to the User or anyone else should the Service at any given time not be available to the User due to maintenance, updates, technical issues or any other circumstance.

Car Info will not become party to any contracts or agreements with the User through the use of the Service and will under no circumstances be held liable to the User for any legal transactions undertaken through the use of the Service or consequential damages or costs, direct or indirect, either predictable or unpredictable and irrespective of the reason for the claim, derived from the User's use of the Service.

7. Termination

Car Info reserves the right to terminate these Terms of Use with immediate effect if (i) the User violates the terms herein, or (ii) in the event of a third-party claim against Car Info for the User's Use of, or Car Info's provision of, the Service, or (iii) if Car Info ceases to provide the Service for commercial or other reasons, such as changes in laws or regulations, judgments or authority decisions.

Upon termination of these Terms of Use, the User will cease to use the Service with immediate effect.

8. Amendments

Car Info reserves the right to amend these Terms of Use. The User will be notified of any amendments 30 days at the latest prior to the amendments coming into effect. Car Info may also allow amendments to apply immediately if brought about law, provisions, government regulation, court or government decision, or other similar circumstance. Car Info will inform the User of any such amendment without delay and in the manner appropriate to the circumstances. Should the User not accept amendments to these Terms of Use, the User is entitled to terminate the agreement with immediate effect and to stop using the Service.

9. Disputes

Swedish law is applicable for these Terms of Use. Disputes arising from these Terms of Use or the use of the Service will be settled in the General Court with Helsingborg District Court as the first instance.
